1.4 SYSTEM DESCRIPTION

A. Performance Requirements: Provide recycled rubber resilient flooring, which has been manufactured and installed to maintain performance criteria stated by manufacturer without defects, damage or failure.

1.5 SUBMITTALS

- A. General: Submit listed submittals in accordance with Conditions of the Contract and Division 1 Submittal Procedures Section.
- B. Product Data: Submit product data, including manufacturer's guide specifications product sheet, for specified products.
- C. Samples: Submit selection and verification samples for finishes, colors and textures.
- D. Quality Assurance Submittals: Submit the following:
 - 1. Test Reports: Certified test reports showing compliance with specified performance characteristics and physical properties.
 - 2. Certificates: Product certificates signed by manufacturer certifying materials comply with specified performance characteristics and criteria and physical requirements.
 - 3. Manufacturer's Instructions: Manufacturer's installation instructions. Specifier Note: Coordinate paragraph below with Part 3 Field Quality Requirements Article herein. Retain or delete as applicable.
- E. Manufacturer's Field Reports: Manufacturer's field reports specified herein. G. Closeout Submittals: Submit the following:
 - 1. Operation and Maintenance Data: Operation and maintenance data for Installed products in accordance with Division 1 Closeout Submittals (Maintenance Data and Operational Data) Section. 1.6 QUALITY ASSURANCE
